40 FOR the purpose of amending the bases for determining a majority vote

90 WHEREAS: The Standing Rules of Order for the Maryland Student Legislature are based on
100 the principles set forth in Robert's Rules of Order; and,

110 WHEREAS: It is desirable for the Maryland Student Legislature to maintain rules that are
120 reasonably consistent with Robert's Rules of Order; and,

130 WHEREAS: Robert's Rules of Order specifically discourages the use of voting requirements
140 based on the number of members present.

150 SECTION 1. BE IT ENACTED BY THE MARYLAND STUDENT LEGISLATURE, that the
160 Maryland Student Legislature Standing Rules of Order read as follows:

170 **VII MOTIONS**

180 §43. Majority Vote
190 Except as provided otherwise in these Rules, each question shall be determined by a
200 majority ~~vote of the Members present~~ OF THE VOTES CAST BY PERSONS
210 LEGALLY ENTITLED TO VOTE, EXCLUDING BLANKS AND ABSTENTIONS,
220 provided that there is a quorum PRESENT.

230 SECTION 2. BE IT FURTHER ENACTED, that this shall take effect July 1, 2002.
