10 **AN AMENDMENT TO THE STANDING RULES OF ORDER OF THE MARYLAND**
20 **STUDENT LEGISLATURE CONCERNING THE CREATION OF A UNITED STATES**
30 **STUDENT CONGRESS MEMBERSHIP COMMITTEE**

40 FOR the purpose of including a non-legislative committee to the Maryland Student Legislature to
50 recommend, to the General Assembly, the membership for the United States Student Congress.

90 **WHEREAS:** The Constitution of the Maryland Student Legislature requires a committee to be
100 established to recommend the membership, from Maryland, who shall
110 participate in the United States Student Congress; and,

120 **WHEREAS:** The USSC Membership Committee would be a non-legislative committee and
130 thus would require different parameters for floor petitions.

140 SECTION 1. BE IT ENACTED BY THE MARYLAND STUDENT LEGISLATURE, that
150 the Standing Rules of Order of the Maryland Student Legislature read as
160 follows:

170 §61. Committee Design

180 (a) The Following legislative committees shall be established:

- 190 (1) Ways and Means;
200 (2) Commerce and Government Matters;
210 (3) Judiciary;
220 (4) National Affairs;
230 (5) Environment and Public Works;
240 (6) Rules, which shall consist of one Member from each delegation.

250 (b) A Member may not be appointed to more than one of the legislative committees referred to in
260 paragraphs (a)(1) through (a)(5) of this Rule.

270 (c) The Council of State shall establish special legislative committees as are deemed necessary.

280 (D) A NON-LEGISLATIVE COMMITTEE KNOWN AS THE USSC MEMBERSHIP
290 COMMITTEE SHALL BE ESTABLISHED, CONSIST OF ONE MEMBER FROM EACH
300 DELEGATION AND ONLY COME TO ORDER DURING THE ANNUAL LEGISLATIVE
310 SESSION.

320 §62. Committee Reports

330 (a) The Chair of each LEGISLATIVE committee, shall direct the clerk of the committee to
340 prepare a list of the legislation which was recommended favorably or unfavorably. The list shall
350 be transmitted to the Secretary of State.

360 (b) The Chair shall attach to each piece of legislation reported to the floor, a copy of each
370 amendment thereto adopted by the committee.

380 (C) THE CHAIR OF THE USSC MEMBERSHIP COMMITTEE SHALL PREPARE A LIST OF
390 THE TWELVE MEMBERS RECOMMENDED TO BE MEMBERS OF THE UNITED STATES

400 STUDENT CONGRESS. THE LIST SHALL BE TRANSMITTED TO THE SECRETARY OF
410 STATE.

420 SECTION 2. BE IT FURTHER ENACTED, that this shall take effect immediately upon its
430 passage.
