10 **A SIMPLE RESOLUTION CONCERNING THE APPOINTMENT OF THE ANNE**
20 **ARUNDEL COMMUNITY COLLEGE STUDENT TRUSTEE MR. CRAIG E.**

40 **WHEREAS:** Craig E. Reynolds has been a consistently active member of the Maryland
50 Student Legislature, Inc. since the 2002-2003 legislative year; and,

60 **WHEREAS:** Mr. Reynolds was a founding member of the Anne Arundel Community College
70 delegation to the Maryland Student Legislature, Inc. and served as Delegation
80 Chairperson from August of 2003 through October of 2003 and as Vice
90 Delegation Chairperson from May of 2004 till the present time; and.

100 **WHEREAS:** At the 2003 Fall Leadership Training Institute sponsored by the University of
110 Maryland, Baltimore County (UMBC), Mr. Reynolds was elected as the first
120 Comptroller of the Maryland Student Legislature, Inc. and served honorably in
130 that capacity by competently managing the finances of the organization until the
140 end of his term in May of 2004; and,

150 **WHEREAS:** Mr. Reynolds regards public service very highly and felt that he could best
160 represent the views and interests of the approximately 21,000 Anne Arundel
170 Community College students and for that reason became a candidate for the
180 position of Student Trustee on the Anne Arundel Community College Board of
190 Trustees; and,

200 **WHEREAS:** After careful examination and scrutiny by the administration of Anne Arundel
210 Community College and the Governor's Appointments Office, Governor Robert
220 L. Ehrlich, Jr. nominated Mr. Reynolds to the Anne Arundel Community
230 College Board of Trustees to serve as the Student Trustee from July 1, 2005 till
240 June 30, 2006; and,

250 **WHEREAS:** The Executive Nominations Committee and the entire Senate of Maryland
260 reacted favorably and approved Mr. Reynolds nomination as Student Trustee on
270 the Anne Arundel Community College Board of Trustees.

280 **THEREFORE IT BE RESOLVED:** That the Maryland Student Legislature, Inc. congratulates
290 Mr. Craig E. Reynolds on his appointment as Student Trustee on the Anne
300 Arundel Community College Board of Trustees; and,

320 Reynolds the very best as he embarks on a year of public service to the citizens of Anne Arundel
