An Act Concerning

10 **Participation In Dog Fights – Attendance, Participation, and Training**

20 FOR the purposes of stiffer penalties for the attendance and participation in dog fighting.

30 BY repealing, and reenacting, with amendments,
40 Article – Crimes Relating to Animals
50 10-607, 10-605, 10-611

60 SECTION 1. BE IT ENACTED BY THE MARYLAND STUDENT LEGISLATURE,
70 That the Laws of Maryland reads as follows:

80 **§ 10-607. Same - Certain activities related to dogfights prohibited.**

90 (a) *Prohibited activities.*- A person may not:

100 (1) use or allow a dog to be used in a dogfight;

110 (2) arrange or conduct a dogfight;

120 (3) PURCHASE, possess, own, sell, transport, or train a dog with the intent to use the dog in a
130 dogfight; ~~or~~

140 (4) PURCHASE, POSSESS, OWN, SELL, OR TRANSPORT AN ANIMAL TO USE IN
150 TRAINING A DOG TO FIGHT; OR

160 ~~(4)~~ (5) knowingly allow premises under the person's ownership, charge, or control to be used to
170 conduct a dogfight.

180 (b) *Penalty.*-

190 (1) A person who violates this section is guilty of the felony of aggravated cruelty to animals
200 and on conviction is subject to imprisonment FOR A TERM OF NO LESS THAN 2 YEARS
210 AND NOT EXCEEDING 10 YEARS AND A FINE NOT EXCEEDING \$10,000.. ~~not~~
220 ~~exceeding 3 years or a fine not exceeding \$5,000 or both.~~

230 (2) As a condition of sentencing, the court may order a defendant convicted of violating this
240 section to participate in and pay for psychological counseling.

250 **§ 10-605. Attending dogfights or cockfights.**

260 (a) *Dogfighting.*- A person may not knowingly attend a deliberately conducted dogfight as a
270 spectator.

280 (b) *Cockfighting.*- A person may not knowingly attend as a spectator a deliberately conducted
290 event that uses a fowl, cock, or other bird to fight with another fowl, cock, or other bird.

300 (c) *Penalty.*-

310 (1) A person who violates this section is guilty of a misdemeanor and on conviction is subject to
320 imprisonment not exceeding ~~90~~ 180 days or a fine ~~not exceeding \$1,000~~ NOT LESS THAN
330 \$1,000 AND NOT EXCEEDING \$2,500, or both

340 (2) As a condition of sentencing, the court may order a defendant convicted of violating this
350 section to participate in and pay for psychological counseling.

360 **§ 10-611. Killing of dog or cat - Prohibited means.**

370 (a) *Prohibited.*- A person may not kill or allow a dog or cat to be killed by use of:

380 (1) a decompression chamber;

390 (2) carbon monoxide gas; ~~or~~

400 (3) curariform drugs;

410 (4) ELECTROCUTION;

420 (5) HANGING; OR

430 (6) DROWNING.

440 (b) *Penalty.*- A person who violates this section is guilty of a ~~misdemeanor~~ FELONY OF
450 AGGRAVATED CRUELTY TO ANIMALS and on conviction is subject to a SENTENCE OF
460 NO LESS THAN 6 MONTHS OR A fine not exceeding ~~\$500~~ \$1000.

470 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect January 1,
480 2009.
